Public Notice PPGServiço Social nº. 02/2019 Financial University Grants in Brazil not linked to PrInt / UFPE Research Projects (Refer to PROPESQ Notice 03/2019, dated 01/17/2019, modified on 02/14/2019)

This is a public announcement of the Graduate Program in Social Service of the Federal University of Pernambuco (UFPE) for applications and initial selection of grant recipients in Brazil with no links to research projects for the year 2019, for activities financed by the Institutional Project for Internationalization (PII) of this university (UFPE), within the scope of activities financed by the Institutional Program of Internationalization (PRINT) and the Coordination for the Improvement of Higher Education Personnel (CAPES), according to the regulations published in Public Notice nº. 41/2017 of Capes, and the provisions of Propesq Public Notice Nº. 01/2018.

1. Objectives

1.1. The selection of beneficiaries not linked to research projects for the year 2019 of scholarships in Brazil by the Institutional Project for Internationalization (PII) of UFPE, for the graduate programs in Political Science, Social Service and Sociology, seeks to:

1.1.1 Encourage the construction, implementation and consolidation of UFPE's strategic internationalization plans in specific priority areas of knowledge listed below;
1.1.2 Stimulate the formation of international research networks with a view to improving the quality of academic production linked to postgraduate studies;
1.1.3 Expand support for internationalization activities in UFPE post-graduate programs;
1.1.4 To promote the mobility of teachers and students, with emphasis on doctoral students, postdoctoral students and professors to go abroad and from abroad to UFPE, linked to *stricto senso* graduate programs with international cooperation;
1.1.5 Encourage the transformation of UFPE into an international environment;
1.1.6 Integrate other UFPE-promoted activities with internationalization efforts.

2. Theme, modalities of grants, values and vacancies

2.1 Theme: State and society in the contemporaneous world: global contemporaneity: dynamics of inequality and development

State and society are threatened by global risks resulting from a variety of processes and relationships, presented in 3 thematic blocks as follows: a. DEMOCRACY, INEQUALITIES AND DEPRIVATION OF RIGHTS; HUMAN RIGHTS AND INEQUALITIES; SOCIAL STRUGGLES, WOMEN'S MOVEMENTS AND CONFRONTATION OF INEQUALITIES; PERIPHERAL CAPITALIST DEVELOPMENT: Impacts and social, political and environmental conflicts; WORK AND MIGRATION; HOUSING AND MIGRATION: Quality of life of populations. At present, sociopolitical responses that have been presented as an alternative to economic growth, to the reduction of inequalities and to the social consequences on the world population, particularly those in dependent and peripheral capitalist countries, have proved insufficient and not much different from the extant precarious conditions of life and work of these populations. The relationship between development and inequalities will be approached from an analysis of the



suppression of rights and contemporary struggles. b. SOCIAL INEQUALITY IN BRAZIL INTERPRETED IN THE LIGHT OF THE THEORY OF PIERRE BOURDIEU; GLOBALIZATION OF AGRICULTURE AND SOCIAL INEQUALITIES; GLOBALIZATION AND CULTURAL SUPERDIVERSITY Globalization, understood as a worldwide process of economic, sociopolitical, spatial and cultural integration, has generated forms of unequal development in countries of peripheral capitalism: whether at the level of land concentration and the inequalities this generates, or in the distribution and consumption of cultural capital, or in the forms of intellectual production in spaces of power and domination. These dimensions will be analyzed in the light of the new international division of labor; from a theoretical perspective that is key for the discussion of current cultural capital and the relationship between superdiversity and global cultural processes. C. CORRUPTION AND POLITICS The phenomenon of corruption is seen as a practice that affects the functioning of politics, of representation, with consequences for the quality of public policies and international relations. The purpose of this theme is to develop ways of measuring corruption, building reliable indicators and databases and to identify the causes of corruption and its effects on political behavior, public policy and international relations.

3. Requirements

3.1 The applications must obey the norms of Capes publication n^o. 41/2017, in accordance with the requirements and procedures established by the regulations of Capes, in addition to the following requirements. The applicant will:

3.1.1 Make the application through the Coordinator of the Graduate Program in the Institutional Internationalization Project of UFPE within PrInt / Capes;

3.1.2 Be a professor or researcher with recognized competence in his or her special area;

3.1.3. Be the holder of a doctorate degree;

3.1.4 Have scientific production in the area of the Graduate Program where the grant activity will take place;

3.1.5 Acknowledge that failure to comply with these requirements will disqualify the application;

3.1.6 Submit a signed statement stating that:

3.1.6.1 The applicant is committed to the work plan and its respective schedule of activities.

4. Timeline (modified by rectification of the announcement published on 02/14/2019)

4.1 The selection process of this notice will occur according to the schedule below:

4.1.1 Publication of the notice: January 17, 2019;

- 4.1.2 Final date for submission of proposals: April 30, 2019;
- 4.1.3 Publication of results: by May 17, 2019;
- 4.1.4 Implementation of the Grants: starting in June, 2019.



5. In-country grants

5.1 Visiting Professor in the Country: to attract well-known professors who reside abroad to teach in Brazil, to offer training, give lectures or conduct face-to-face seminars during the grant period as part of the Institutional Internationalization Project (PRINT);

5.2 Young Talent with Experience Abroad: for talented young Brazilian or foreign researchers, residing abroad with proven international academic-scientific experience (such as master's or doctorate degrees, or master's or doctorate sandwich for at least twelve months) for the accomplishment of research activities or teaching, within the duration of the Institutional Internationalization Project;

5.3 Post-Doctorate with experience abroad: to attract researchers or professors, Brazilian or foreign, residing in Brazil or abroad who have relevant academic-scientific experience abroad (as a full or postdoctoral student for a minimum of 12 months), to carry out research or teaching activities, within the grant period of the Institutional Internationalization Project;

5.4 In the teaching activities carried out by any one of the fellows in the country, in the modalities described above, a recording must be made for online transmission and subsequent availability, whenever possible.

6. Submission of Proposals

6.1 Proposals should be sent on line by the candidates to the coordinator of the Post-Graduation in Social Work containing the following: Work plan; time schedule of activities; statement signed by the applicant affirming the agreement to carry out the Work Plan within the stated timeline; and a summarized curriculum.

6.2. The Work Plan should have a maximum of fifteen thousand characters, with a schedule of the activity plan, including any specific experimental or laboratory infrastructure involved. It must contain the following items:

a) Title (Title);

b) Introduction and justification, presenting current information that is relevant to the theme;

c) Objectives, defining and limiting the object of study;

d) Timeline with schedule of activities;

e) Contribution of the work plan to the promotion of teaching, training and learning, where applicable;

f) Potential for an expansion of the research and education network, with new techniques and partnerships, and wide dissemination of the results, as applicable;

g) Relevance for the scientific and technological development of the area of study in Brazil, both in the medium and long term;

h) Relevance to the medium and long-term development of both economic and social welfare of Brazil, as applicable;

i) Provision for and compliance with national and international standards, where relevant.

6.4 Proposals accepted by the PPGSS will be sent by the coordinator of the Post-Graduation Program in Social Work, by completing an electronic form, available on the Propesq website or at https://goo.gl/forms/zkeKjpvle4debmi53, according to the time frame set forth in item 4.

6.5. The PPGSS can send as many proposals as it wishes, since the selection will be the responsibility of the PRINT Management Committee, from proposals forwarded by both the Postgraduate Program in Political Science and the Postgraduate Program in Sociology.



7. Analysis and Criteria for Judging Applications

7.1 The applications submitted by the Postgraduate Programs to Propesq will be analyzed by the PII / UFPE Management Group, according to criteria that include:

7.1.1 Relevance of the proposal to the themes;

7.1.2 Impact of the proposal on the improvement of research performance and the internationalization of the postgraduate program;

7.1.3 Feasibility of execution of the work schedule, considering the period of permanence and the infrastructure of the PPG;

7.1.4 Establishment a partnership with institutions in the countries with which Capes maintains effective cooperation (listed in Annex I).

7.2 The analysis of merit will be preceded by a technical analysis of the conformity of the proposals to the terms of this Notice, to the norms of the Capes Notice no. 41/2017, as well as to the procedures established by Capes in its normative instruments (Public Notice Capes n° 186, of September 29, 2017, n° 201 and n° 202, of October 16, 2017, n° 08, of January 12, 2018, and other relevant instruments).

8. Results and Implementation of the grant

8.1 The results will be published in the pages of Propesq (<u>www.ufpe.br/propesq</u>) and PrInt / UFPE (<u>www.ufpe.br/print</u>), observing the schedule set forth in item 4;
8.2 After the disclosure of the results, Capes will inform the PPG coordinator of the procedures for implementing the grant.

9. Administrative Resources

9.1 The period for appeal shall be up to 02 (two) business days from the date of publication of the result and if no reason for suspension is given, the appeal should be referred to the IIP Management Group at UFPE.

10. Final Provisions

10.1 At least 70% of UFPE IIP resources should be earmarked for partnerships with institutions in countries with which Capes has effective cooperation (listed in Annex I); 10.2 Any omissions in this Notice will be referred to the IIP Management Group at UFPE.
